EXERCISE MY LEGAL RIGHTS;

ANSWER YOUR QUESTIONS.

IF I AM DETAINED, I HAVE THE RIGHT TO
CONTACT AN ATTORNEY IMMEDIATELY.

I REFUSE TO SIGN ANYTHING WITHOUT
ADVICE FROM AN ATTORNEY.
